Foundation Report	<ul> <li>Ms. Wettlaufer gave the following highlights:</li> <li>The spring direct mail was sent out in May. A full report will come to the September meeting. Proceeds are going towards the CORI Robot Hip software.</li> <li>The May 50/50 winner was William Chute who took home \$49,000. William also won an early bird prize in 2023.</li> <li>The YTD proceeds from the 50/50 is just over \$1.9M.</li> <li>Although the Dairy Capital Run was rained out, it was still successful with \$22,980 in proceeds. This is \$27 shy from last year.</li> <li>The Golf Tournament was another huge success with 228 golfers and \$125,000 in sponsorship.
